To date, we have donated more than half of a sea container which will be distributed in Mexico.

The Wheelchair Foundation has invited Knights from Ontario to assist with the distribution of these wheelchairs. They have put on hold 20 Air line seats, and 10 Hotel rooms at the GRAN MELIA MEXICO REFORMA in Mexico City for Wed Feb 13 to Mon Feb 18th, 2008.

Attached to this letter is a flyer outlining the itinerary for this trip. In addition to this they have scheduled:

- Thursday: a bit of free time, visiting the city and local churches, with some home distributions
- Friday: a trip to the pyramids, an evening reception at the large Metropolitan Cathedral,
- Saturday: wheelchair distribution, incl. home visits, to Texcoco (one hour drive one way)
- Sunday: wheelchair distribution and mass at the Basilica

The Knights at the Basilica of the Lady of Guadalupe are looking forward to hosting us. Chris Lewis, Director of Public Education/Development for the Foundation (son of actor Jerry Lewis), is joining us on this trip.

This is a great opportunity for 20 Knights and family members across Ontario to come together in the spirit of putting our charity into action.
